Project Review: Tony reviewed the accomplishments of the board from August 2017 through August 2018:

- Established avenues of communication with members: bi-annual newsletter and website <u>www.manchesterparkhoa.com</u>

- Question about investors/rental companies was shared Manchester Park By-Laws note that 'For Rent' signs are not allowed in the community. However, we cannot prevent homeowners from renting out their properties.
